In lieu of taking the class for credit, you may choose to audit the course. Please discuss this with your advisor.
- ** Other coursework includes the following: electives, additional methods courses, Research Practicum, or Research Residency.
- *** International students may request a waiver for this course if they do not expect to work in the U.S. after graduation.

NOTES

- All students must have at least one interdisciplinary experience, which can be achieved through the "other coursework" listed above.
- Research Practicum courses and cognates can be taken during the summer.
 Research Practicum courses can be taken anytime during the program; they are slotted in the POS as an example.
- Research Residency (NURS:7509) can be taken for 1-3 s.h. (semester hours), and there are no limitations on how many times it can be taken. It can be taken during the summer.

All doctoral programs will contain a minimum of 72 semester hours of graduate work. Of those 72 semester hours, at least 39 must be earned while registered in The University of Iowa Graduate College, and after formal program admission. For example, the academic registration requirement cannot be fulfilled by coursework completed under the non-degree or non-departmental student classification or with transfer credit. This means that students can have credit for up to 33 hours from their master's or DNP program.
